2. Hazard identification

No particular hazards known.

3. Composition/information on ingredients

Chemical nature
Sodium Polyacrylate, E124 Ponceau 4R (Red food colouring)

4. First-aid measures - (relevant to undiluted, dry, powder)

General advice:
Remove contaminated clothing.

If inhaled:
If difficulties occur after dust has been inhaled, remove to fresh air and seek medical attention.

On skin contact:
Wash thoroughly with soap and water.

On contact with eyes:
Wash affected eyes for at least 15 minutes under running water with eyelids held open.

On ingestion:
Rinse mouth and then drink plenty of water.

Note to physician:
Treatment: Treat according to symptoms (decontamination, vital functions), no known specific antidote.

5. Fire-fighting measures

Suitable extinguishing media:
water spray, dry extinguishing media, foam

Unsuitable extinguishing media for safety reasons:
carbon dioxide, water jet

Special protective equipment:
Wear a self-contained breathing apparatus.

Further information:

Contaminated extinguishing water must be disposed of in accordance with official regulations. The degree of risk is governed by the burning substance and the fire conditions.

6. Accidental release measures

Personal precautions:
Breathing protection required. Avoid dust formation.

Methods for cleaning up or taking up:
For large amounts: Contain with dust binding material and dispose of.

7. Handling and storage

Handling

Handle in accordance with good industrial hygiene and safety practice.

Breathing must be protected when large quantities are decanted without local exhaust ventilation. Avoid the formation and deposition of dust.

Protection against fire and explosion:

The relevant fire protection measures should be noted. Take precautionary measures against static discharges. The product contains combustible polymers.

Storage

Further information on storage conditions: Keep container dry because product takes up the humidity of air.

8. Exposure controls and personal protection

Components with workplace control parameters

A safe working level of 0.05 mg/m³ has been established for respirable dust (< 10 µm diameter) by the German MAK commission.

Personal protective equipment

Respiratory protection:
Breathing protection if dusts are formed.

Hand protection:

Chemical resistant protective gloves (EN 374)
nitrile rubber (NBR) - 0.4 mm coating thickness
chloroprene rubber (CR) - 0.5 mm coating thickness

Eye protection:
Safety glasses with side-shields (frame goggles) (e.g. EN 166)

General safety and hygiene measures:
Handle in accordance with good industrial hygiene and safety practice. Wearing of closed work clothing is recommended.

10. Stability and reactivity

Hazardous reactions:
The product is not a dust explosion risk as supplied; however the build-up of fine dust can lead to a risk of dust explosions. Accumulation of fine dust may entail the risk of a dust explosion in the presence of air. Dust explosion hazard.

No hazardous decomposition products if stored and handled as prescribed/indicated.

11. Toxicological information

Acute toxicity

LD50 rat (oral): > 2,000 mg/kg
LD50 rat (dermal): > 2,000 mg/kg

Irritation

Primary skin irritation rabbit: non-irritant (OECD Guideline 404)
Primary irritations of the mucous membrane rabbit: non-irritant (OECD Guideline 405)

Sensitization

No sensitizing effect.

Carcinogenicity

Assessment of carcinogenicity:
A chronic (2-year) lifetime inhalation study in rats with respirable dust (micronized to < 10 µm diameter) resulted in a non-specific inflammatory response in the lungs followed by tumor development in some rats in the highest chronic exposure level of 0.8 mg/m³. In the absence of chronic inflammation, tumours are not expected.

Other relevant toxicity information

The statement was derived from products of similar composition.

12. Ecological information

Ecotoxicity

Toxicity to fish:

LC50 (96 h) > 100 mg/l, *Brachydanio rerio* (OECD Guideline 203, static)

Aquatic invertebrates:

EC50 (48 h) > 100 mg/l, *Daphnia magna* (OECD Guideline 202, part 1, static)

Aquatic plants:

EC50 (72 h) > 100 mg/l, *Desmodesmus subspicatus* (OECD Guideline 201)

Nominal concentration.

Micro organisms/Effect on activated sludge:

The inhibition of the degradation activity of activated sludge is not anticipated when introduced to biological treatment plants in appropriate low concentrations.

Soil living organisms:

LC50 > 1,000 mg/kg, *Eisenia foetida* (OECD Guideline 207)

Persistence and degradability

Assessment biodegradation and elimination (H2O):

The product is not very soluble in water and can thus be removed from water mechanically in suitable effluent treatment plants.

Other adverse effects

The product contains: ≤ 20 (W/W) PPM total amount of heavy metal as Pb

Additional information

Due to the consistency of the product, dispersion into the environment is impossible. Therefore *no negative effects on the environment may be anticipated* based on the present state of knowledge.

Other ecotoxicological advice:

Do not release untreated into natural waters. The ecotoxic effect of the product has not been tested. The information on this was derived from products of similar structure or composition.
